- V. Treasurer's Report:
 - A. \$56,353.36 has come in for 2011. We spent \$1,012.05 for office staff /professional services. We also spent \$565.00 of the remaining 2010 road funds. We have approximately 891 paid members for 2011.
 - B. Review of the 2005-2010 books by Dr. Roberta Ann Barra Ph.D., CPA, University of Hawaii at Hilo Accounting Professor, showed the books clear though 2008; 2009 and 2010 were too messy to fix as it would take a lot of money to research and clean up. Dues for 2011 were received and deposited in 2010 so budget at start of 2011 was not accurate. Will use dues recorded in 2011 as start of budget year.
 - C. Accountant said that reserves of \$2500 to \$3000 will not endanger our tax exempt status.
 - D. Account balances approximately \$39048. need to subtract approximately \$15000 till the end of the year for expenses and committed projects leaving \$24,000 to divide for end of year, giving each road \$3000.
