Old Business

- Policy & Procedure Manual Update Margie has completed the financial section, the rest in progress per Devra.
- Zoom Update- No zoom today, tech difficulties, paid \$187.43 for renewal, extra storage and extension fee. Transcripts are available and recordings according to Geneva.
- <u>SB321 & SB124</u>- State hearings were held. SB321 pertains to private road issues and is still advancing, SB1244 regarding fuel tax sharing; dead for this session.
- <u>GE Taxes and 1099's to vendors</u> Margie says both were complete and mailed. Devra inquired about online access and Geneva said she can help get online access. Kaipo and Jordan would discuss streamlining of taxes. Jordan said the IRS says we didn't do 2023 + 2024 990 EZ. Kaipo mentioned online submission as well. Needs follow-up.
- <u>Website update</u>- Geneva says Gerda updated the website with agenda/zoom/new officers. Jordan suggested maybe in the future Kaipo could help. Gerda is a volunteer and is willing to keep helping. Devra said she would add Gerda's contact info. to our internal contact sheet.
- Mandatory Road Fees- Jordan looking into ways to fund an attorney, still moving forward. To be continued...

New Business

- New Storage rental HARC Documents- According to Geneva \$25 per month is the price for a storage closet sized space. HACA has closed their storage space. The \$25/month is enough space to store everything currently housed at Geneva/Margie/Devra's homes. Kaipo asked if it could be converted to digital copies. Jordan offered temp. storage at his house as we work towards digitization. Motion by Shannon, 2nd by Brad; all in favor. Devra offered to donate a scanner/printer and all seemed to be in favor. Kaipo requested that an agenda item for next meeting be re: digitization.
- Extend the vote re: Mandatory Road Fees. More input needed, defer- Motion by Kaipo, 2nd by Shannon; all in favor.
- Emergency funds allocation-roadside mowing. Motion by Marie to remove from agenda, 2nd by Devra, all in favor.
- <u>Postcard dues reminder/ mandatory dues update for members</u>- Motion by Kaipo to revise into next agenda re: QR code and a public outreach campaign, 2nd by Brad. Marie asked if a special meeting was still needed.
- <u>Call for treasurer and check signer</u>- Motion by Devra, 2nd by Marie to add Kaipo as a check signer, all in favor. Alex/Joanna to take checks to bank- Motion by Shannon, 2nd by Marie, all in favor. Margie mentioned that PayPal donations go into Savings Account and she manually moves into Checking. She said she can train Kaipo to work on online banking and electronic reconciliation. Motion by Shannon that Margie, Joanna, and Kaipo work out the details on banking and treasurer duties and report back, 2nd by Linette, all in favor.
- Jordan discussed adding gathering/supporting testimony for road funding in support of Bill 82 to the County budget which will be heard at County Council on May 22nd at Shannon's suggestion.

Public Comments: Gary Rosenburg has a suggestion for animals to be used in both regenerative farming and road maintenance, he asked for time during the next meeting to discuss further. Kaipo requested an email proposal. Chuck Furtado mentioned an idea where each homeowner repair the road in front of their own property. Lori said she is doing that already. Board members seemed to unofficially support this idea. Another comment re: 1 rd. and Jordan said that he had run out of steam because the community wasn't supporting. Trudy seconded Chuck's comment and said that road reps need to educate people on how to make repairs appropriately. Request made by Shannon to take some public comments at the beginning of the agenda for the next meeting.
